

## **LessonKit Twitch Extension Terms of Service**

### **Introduction**

These terms and conditions apply between you, the User of this Twitch Extension and Codices Interactive Ltd., the owner and operator of this Twitch Extension. Please read these terms and conditions carefully, as they affect your legal rights. Your agreement to comply with and be bound by these terms and conditions is deemed to occur upon your first use of the Twitch Extension. If you do not agree to be bound by these terms and conditions, you should stop using the Extension immediately.
